



NOTIFICATION

Application in the prescribed format are invited from the eligible Assistant Professor / Associate Professors of the University satisfying/ meeting the **API based PBAS requirement** and other eligibility conditions laid down in the **UGC Regulation on Minimum Qualification for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measure for the Maintenance of Standards in Higher Education 2010** and **UGC (Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) (2nd Amendment Regulation, 2013** for consideration of **promotion under Career Advancement Scheme (CAS)** as per the provisions contained in the said **UGC regulation 2010** notified vide UGC letter No. F.3-1/2009 dated 30.06.2010 and letter No. 1-2/2009 (EC/PS)Pt.VIII dated 07.12.2012 and **UGC (2nd Amendment) Regulations 2013** notified vide letter No. F.1-2/2009(EC-PS) V(i) Vol-II dated 13th June 2013 (**3rd Amendment**), as per the following :

- From **Assistant Professor (Stage – 1) to Assistant Professor (Stage – 2)** in the PB – III (Rs. 15,600 to 39,100) with AGP Rs. 7,000/-.
- From **Assistant Professor (Stage – 2) to Assistant Professor (Stage – 3)** in the PB – III (Rs. 15,600 to 39,100) with AGP Rs. 8,000/-.
- From **Assistant Professor (Stage – 3) to Associate Professor (Stage – 4)** in the PB – IV (Rs. 37,400 to 67,000) with AGP Rs. 9,000/-.
- From **Associate Professor (Stage – 4) to Professor (Stage – 5)** in the PB – IV (Rs. 37,400 to 67,000) with AGP Rs. 10,000/-.

The teachers of the University who consider themselves eligible for promotion under CAS are required to submit their bio-data with duly filled in the prescribed proforma based on Performance Based Appraisal System (PBAS) enclosed as **Annexure – A** along with reprints of **minimum three publication** in case of promotion from **Assistant Professor (Stage – 3) to Associate Professor (Stage – 4)** and reprints of **minimum five publications** [published subsequent to the date of placements as Assistant Professor (stage – 3)] in case of promotion from **Associate Professor (Stage – 4) to Professor (Stage - 5)** in **Two sets** with the relevant documents, for consideration for promotions under CAS.

The Deans of the schools / Heads of the Departments are requested to circulate the Notification amongst the Assistant Professors / Associate Professors (including those who are on leave) and forward their application in the prescribed format duly checked and verified about the correctness of the entries recorded therein.

The case for promotion under Career Advancement Scheme shall be regulated as per the guidelines of the UGC contained in the **UGC Regulation on Minimum Qualification for Appointment of Teachers and other Academic staff in Universities and Colleges and measures for the maintenance of standard in Higher Education 2010** and **UGC (Minimum Qualification for appointment of teachers and other Academic Staff in Universities and colleges and measures for the maintenances of standards in Higher Education) (2nd Amendment) Regulations, 2013** referred as above and those received from time to time in this regard. The applicants may visit these websites and see the said regulations for details of the scheme, eligibility, requirements etc. for promotion under CAS.

The application completed in all respect with required relevant documents shall be submitted to the Registrar Central University of Karnataka, Kadganchi, Aland Road, Gulbarga 585 311 within 30 days from the date of notification.
