**Name of the position: CONSULTANT CAMPUS DEVELOPMENT**

**Qualification & Experience:** A Bachelor's degree in Engineering preferably Civil/Electrical Engineering. A highly experienced Engineering Professional having a track-record of planning/handling/executing large construction plans in the capacity of a Senior Official in Govt. or Public funded autonomous organization/ bodies. Preference would be given, if found equally suitable to others, to persons superannuated from the position of Superintending Engineer or higher and having functioned on position(s) in such public sector organizations with any Grade Pay in Pay-Band-IV or in Pay Band-III with Grade Pay of Rs. 7600 as per 6<sup>th</sup> Pay Commission of Central Govt. or their equivalent in State Govt. /Autonomous Bodies /PSUs etc.

1. Advisor for Campus Development matters of the University.
2. Providing guidelines and helping in Project Construction and Infrastructure development, liaising with local authorities.

- (iii) Experience: Working experience in organizing national and international training programs, visits & branding of institutes of at least 5 years after graduation or 3 years

**Job Requirement:-** Should be conversant with:

- (i) Dealing with the issues of general administration / finance / & accounts / Budget relating to Training / Visitor's Program.
- (ii) Making protocol arrangements in respect of national / foreign delegates of various training programmes from time to time.
- (iii) Coordination with different divisions at the University as per training schedule.
- (iv) Interaction with various Technical Organizations. (v) Handling all CUK training activities.
