Preamble

At present we are offering UG and PG programmes in Economics and the teaching pedagogy is mainly class room learning.

In order to widen the access to higher education and to bring down the cost by using technological advances Massive Open Online Courses (MOOCs) have emerged as a viable model for imparting education, involving conventional and online education. In order to encourage the e-learning along with traditional classroom teaching UGC has issued a regulation titled "Credit Framework for Online Learning Courses through SWAYAM" during 2016. UGC is asking the universities to offer e-courses to their students. In view of this it has become necessary for us to introduce suitable e-courses to our students.

After going through the various e-courses available on SWAYAM it was observed that very few courses are available on core economics papers. Keeping in view the suitability of the courses to our students, our course structure, infrastructure facilities at the department and the first time it is planned to introduce the e-course the following e-course is selected for the ensuing academic semester for PG I sem /UG III sem students

The exam pattern is IA = 25 marks and End sem exam = 75 marks. In order to pass the course, they have to score 10/25 in IA and 30/75 in End sem. But students have passed in IA and failed in End sem exam. Now students are in final semester writing their end sem exam starting from 23 May 2022. In view of this students have to clear this paper in order to get their degree. But they are unable to reappear for this again as it takes one year of their life which will be a hindrance to their future career.

It is also brought to the notice of the committee that there is a provision in NPTL to conduct supplementary exam at the university level as NPTL will not conduct it. In view of this the Dept proposes to conduct the supplementary exam for these students as the paper is related to Economics Discipline as per the course pattern. So keeping in view the students' interest and to help them this agenda requires your approval. The concerned documents like syllabus, course exam pattern and NPTL provision for supplementary exam are enclosed with this agenda for your reference.

Agenda 3 : this refers the same case as described in the agenda no:2 but the student is of IMA V semester having opted NPTL course: Conservation Economics, failed twice, now writing the final semester exams. The course credit is 3 and exam pattern is same as above. This course is offered by IIT Kanpur. The case is similar to the one mentioned in agenda 2. The details of the course are attached herewith for your reference. The dept wants to conduct supplementary exam for which BOS approval is requested.
