How to Reach CUK

Kalaburagi (formerly known as Gulbarga) is accessible by airways, railways and roadways from all parts of India. Nearest international airport to Gulbarga is located in Hyderabad, at a distance of nearly 230 km from Kalaburagi. The city is well connected with all major cities of India like Bangalore, Hyderabad and Chennai through number of regular trains. Buses also operate regularly between Kalaburagi and cities like Bangalore, Hyderabad and Mumbai.

The safest and faster way to reach CUK is by KSRTC bus from Kalaburagi Central Bus Stand. The Central Bus Stand is easily accessible by city buses plying frequently or by auto-rickshaws. The buses going to Aland and Solapur (usually found in platform 10 at Central Bus Stand) will stop at the CUK Campus, Kadaganchi.

Central University of Karnataka

The Central University of Karnataka (CUK) has been established by an Act of the Parliament (No. 3 of 2009) at Kalaburagi, Karnataka. It is one of the 16 Central Universities established by the Government of India during the UGC XI Plan Period to address the concerns of 'equity and access' and to increase the access to quality higher education by people in less educationally developed districts which have a Graduate Enrolment Ratio of less than the national average of 11%.

The CUK, with its territorial jurisdiction all over Karnataka has been initiated its activities from the academic year beginning August 2009 in keeping with the philosophy of achieving and maintaining the highest levels of academic excellence, sensitivity to equity and access in enrolment and recruitment and emerging as a premier national educational and research institution in the country. The University has 654 acres campus, situated near Kadaganchi village in the district of Kalaburagi, Karnataka State (30 km from Kalaburagi city towards Solapur). The main objective of the University is integrating the components of Teaching, Research, Innovation, Training and Skill Development (TRI-TSD) with an aspiration to excel in dual degree, post graduate and doctoral programs. The University offers the programs in following five dominant areas: Arts, Humanities, Management, Sciences, and Engineering. Currently the University is running 16 Departments spread in 8 Schools and 1 Centre, and offering 9 Dual degree programs, 15 Master degree programs, 16 Research (PhD) programs.

Skill Development Cell

In order to facilitate offering of nationally standardized skill related programmes, the Government of India has notified the National Skills Qualifications Framework (NSQF) on 27th December 2013. It is a nationally integrated education and competency-based skill framework which provides for multiple pathways, both within vocational education and between general and vocational education, to link one level of learning to another higher level and enables learners to progress to higher levels from any starting point in the education and / or skill system. It permits individuals to accumulate their knowledge and skills and convert them, through testing and certification by the competent authorities, into higher level of certification which could be a certificate, diploma, advanced diploma, a degree or a PG diploma in common parlance and B.Voc courses. The Central University of Karnataka started its Community college activities in 2013. In 2015, the Community College and B.Voc courses are brought under Skill Development Cell at CUK for better coordination. The following courses are offered at present:-

1. UGC Community College-Diploma in Tool Engineering
2. B.Voc in Horticulture (Food Processing)
3. B.Voc in Sugar Technology

National Seminar

The cover page should not be a part of the paper so as to facilitate peer review of the paper. References should be given at the end of the paper and should be as per the APA 6th edition style.
