Reopening of registration for admissions to PG programmes at Central University of Karnataka for the academic year 2024-25

1. Due to the availability of the few seats in select Departments the registration portal is being reopened for registration into PG programmes at CUK. Candidates are advised to visit the online dynamic vacancy list for the PG programmes.
2. Candidates interested in admission for PG programmes at Central University of Karnataka have to **mandatorily register** in the *CUK-SAMARTH portal* {<https://cukcuetsamarth.edu.in/pg/>} displayed on the CUK website.

Only the candidates who have applied to CUET (PG) – 2024 and qualified in CUET (PG) – 2024 or valid GATE in appropriate subjects are eligible for registration (for more details about the eligibility for admissions to different programmes see prospectus published on the CUK website www.cuk.ac.in).

All candidates must pay the non-refundable registration fee as per the following:

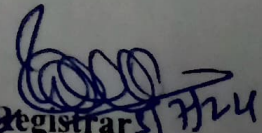

3. Candidates applying for different programmes should pay separate registration fee.

- Admissions for CUK will be done only through the CUK portal (i.e., online mode only)
- Fee payment will be only through the CUK portal (online payment)
- The University will not be held responsible for any delay on the part of the candidates
- The University shall not be responsible for technical glitches or delay, if any, in the payment of the fee.

5. The candidates applying under the reserved categories shall submit category certificates (SC/ST/OBC Non-Creamy Layer Certificate/ EWS) issued by the competent authority in the prescribed format at the time of registration and produce the same in original for verification at the time of admission. The candidates are advised to visit the website for the concerned certificate format.
6. All the prospective Candidates are advised to keep ready with good quality scanned copy (JPG/ PDF format, size not exceeding 500kb for each document) of the following documents (as applicable) for uploading during online registration process.
 - Passport size Digital Photograph
 - Secondary School (10th standard) Marks Sheet
 - Senior Secondary School/PUC-II (12th standard) Marks Sheet or equivalent.
 - Valid Certificate for Date of Birth
 - Migration Certificate from last attended Board, if available
 - School Leaving Certificate/Transfer Certificate/, if available
 - Caste Certificates (ST/SC/OBC-NCL), EWS Certificates, if applicable, issued from the competent authority in GOI format.
 - Self-Declaration Form for those applying under OBC-NCL category, if applicable.
 - PWD/PH Certificate for those applying under the differently-abled category, (if applicable, issued from the competent authority in GOI format).
 - Certificate of Kashmiri Migrant & Kashmiri Pandits / Kashmiri Hindu Families (Non-migrants) for those applying under the Kashmiri Migrant quota (if applicable, issued from the competent authority in GOI format).
 - Certificate(s) as a proof of Ward of Defence Category, if applicable
 - Certificate(s) of representing International, National or State level events in any sports / game for those applying under sports quota, if applicable
 - All the relevant Certificate(s) related to NCC/NSS Category, if applicable
 - Kalyana Karnataka Region (371J) Certificate, if applicable
 - Undertaking form in the case of non-submission of any required Certificates, if applicable
 - Free-ship card for SC/ST candidates from free-ship sanctioning agencies, if applicable.
7. Ensuring the eligibility before applying to a particular programme will be the sole responsibility of the candidate. Please read the eligibility criteria and other requirements before submitting the registration form. Submission of the online registration form is mandatory for admission to the PG programmes.
8. Candidates are advised to visit the CUK website (www.cuk.ac.in) regularly for updates about the admissions, further information and guidelines.
