All Deans/Coordinators/Directors are informed to communicate to all Professor(s)/Associate Professor(s)/Assistant Professor (s) under their control regarding their enrollment to the North-East Teachers MLC Constituency electoral roll and submit duly filled applications along with necessary documents to the **Office of Registrar latest by 06-01-2020.**
