NOTICE TO STUDENTS OF CUK INTEGRATED PROGRAMS

The students those who had been admitted to integrated programs during 2013-14 and got CGPA 6 and above are eligible to get direct admission to their respective PG program. After their admission, the leftover seats will be filled by the candidates who come through the CUCET entrance examination. Hence, the eligible integrated program students are requested to pay their fees on or before 15th June, 2016 to claim their seats. If they fail to do that, the seats will be allotted to the candidates who come through CUCET entrance examination.

*All M.A. Economics have to pay additional amount of Rs. 4,000/- towards uniform as one-time fee at the time of admission.

The students have to bear expenditure for field work which is applicable for all PG Programs which have field work as a component in their curriculum.

Fees have to be paid through challan to University Account and the receipt has to be deposited with the concerned HOD.

Alternatively, the same fee can be paid through any branch of CANARA BANK in India vide NEFT / RTGS and the details are given below:

Important Note:

- SC and ST students whose parental income is less than Rs.2.50 lakhs are not required to pay extracurricular, medical insurance fees, exam fee as the same shall be adjusted against their scholarships (Note: SC/ST students whose parental income is more than Rs.2.50 lakhs are not entitled for this exemption).

Contd.....2

- The students belonging to SC/ST must give an undertaking at the time of admission by stating that *"if the scholarship for any reason is not sanctioned by the concerned government authorities then all the dues shall be cleared by him/her"*.
- All girl students belonging to the economically weaker section, having their parent's annual income less than Rs.6 lakhs are exempted from paying tuition fee upon the production of the income certificate in the format prescribed by Govt. of India from the competent authority.
- All the students are informed to keep the copy of all challans till the end of course.
