16.Multidisciplinary / interdisciplinary

Central University of Karnataka (CUK), Kalaburagi, is one of the newly established central universities in the country under an Act of Parliament in 2009 by the

Government of India. CUK is funded by the University Grants Commission (UGC). The main objective of this rapidly growing CUK is to integrate Teaching, Learning, Training, Research & Innovation, and Skill Development with an aspiration to excel in undergraduate, integrated, postgraduate, and doctoral programmes. CUK offers programmes in six areas: Arts, Humanities, Social Work, Management, Sciences, and Engineering. Currently, CUK is running 27 Departments under 13 Schools and 3 Centres and also offers 03 Integrated degree programmes, 07 stand-alone UG Programmes, 26 Master's degree programmes, M.Phil. programme, and 29 Research (Ph.D.) programmes.

Special Features of the University

20. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

Definition Outcome-based education (OBE) is a student-centric teaching and learning methodology in which the course delivery and assessment are planned to achieve stated objectives and outcomes. It focuses on measuring student performance i.e. outcomes at different levels. Some important aspects of the Outcome Based Education

- 1. Course is defined as a theory, practical, or theory cum practical subject studied in a semester. For Eg. Engineering Mathematics
- 2. Course Outcome (CO) Course outcomes are statements that describe significant and essential learning that learners have achieved, and can reliably demonstrate at the end of a course. Generally, three or more course outcomes may be specified for each course based on its weightage.
- 3. Programme is defined as the specialization or discipline of a Degree. It is the interconnected arrangement of courses, and co-curricular and extracurricular activities to accomplish predetermined objectives leading to the awarding of a degree. For Example: B.E., Marine Engineering
- 4. Programme Outcomes (POs) Program outcomes are narrower statements that describe what students are expected to be able to

- 5. Program Educational Objectives (PEOs) The Educational Objectives of a program are the statements that describe the expected achievements of graduates in their career, and also in particular, what the graduates are expected to perform and achieve during the first few years after graduation.
- 6. ProgrammeSpecific Outcomes (PSO) Programme Specific Outcomes are what the students should be able to do at the time of graduation with reference to a specific discipline. 1.3 - Curriculum Enrichment

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The University has more than 180 classrooms, 23 department-level seminar halls, one computer centre with 60 computers, and more than 590 computers located in departments for academic use. In

addition to the above, the university has a central sophisticated instrumentation centre with a classroom complex and two auditoriums with 350 capacities each for organizing various conferences/seminars. The classrooms are enabled with LAN/Wi-Fi and smart board facilities. The seminar halls are equipped with the necessary ICT facilities. The University also has a video centre that can be used for developing MOOC content and other purposes. Students use the computing laboratories as browsing centres in addition to the University computer centre. All the available facilities are effectively used for teaching-learning purposes.
