For the engagement on contractual basis, faculty shall be paid a remuneration of Rs. 40,000/- for candidates possessing UGC/CSIR-NET and Rs.45,000/- for candidates possessing UGC/CSIR-NET along with Ph.D. in the relevant subject. The positions are purely contractual. Selected candidate will have no right whatsoever to claim absorption/regularization in the University. No TA/DA will be paid for appearing for the interview.

No other emoluments/allowances/Medical reimbursement are applicable. No vacation salary is payable; No Compensatory leaves are applicable.

Please Note: Remuneration will be negotiated based on the experience of the candidate.

General Information

- Candidates must write their Email ID neatly and correctly for mailing written examination/ interview/appointment letter as attachment. The e-mail date will be considered as the official date of dispatch and receipt of communication. - The University shall verify the antecedents or documents submitted at any time at the time of
 engagement or during the tenure of service. In case, it is detected that the documents submitted are fake
 or the candidate has clandestine antecedents/background and has suppressed the said information,
 his/her services shall be terminated forthwith.
- 3. Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET.
- 4. Fake/derecognized Institutions: Candidates, who have obtained degrees or diplomas or certificates for various courses from any Institution declared fake/derecognized by the University Grants Commission, New Delhi shall not be eligible for being considered for recruitment to the posts advertised.
- 5. No person shall be recruited unless he/she is in good mental and bodily health and free from any physical defect that is likely to interfere with the efficient performance of his official duties. Before a candidate recruited directly is finally approved for appointment to the establishment he shall be required to produce a medical certificate of physical fitness from whom the appointing authority specifies.
- 6. Retired teachers, below the age of 65 may also apply.
- 7. Candidates offered the position will have to join within one week and should produce the original marks cards and testimonials along with address proof at the time of joining.
- 8. Original grade card / Marks sheet of Ph.D. Course work must be produced wherever applicable.
- Age qualifications, etc. shall be reckoned as on the last date of submission of application form/date of Interview.
- 10. No increment/enhancement of remuneration on account of completion of Ph.D. will be entertained during the period of Semester / Contract.
- 11. Errors and omissions in notification and selection process are subject to corrections.
- 12. The University has no compulsion to issue an experience certificate having worked as contract faculty. The work order itself shall be the proof for such request.
- 13. The University reserves the right to withdraw any advertised post(s) at any time without giving any reason or change or alter the number of vacancies against any of the posts advertised or not to fill any vacancy.
- 14. At the time of Interview candidates have to produce the original certificates / testimonials / books / published research papers/etc.
- 15. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
- 16. No interim correspondence shall be entertained.
- 17. Candidates appointed shall not be entitled to claim for any weightage for regular appointment / position in the University at a later date.
