Central University of Karnataka having its principal office at Aland Road, Kalaburagi-585 367 (hereinafter referred to as 'CUK' or 'Party' or 'University') collectively referred to herein as the 'Parties' or 'Institutes'. (The implementation of MoU shall be done at the School of Humanities and Languages)

And

The **PALI INSTITUTE (International Institute of Pali Sanskrit and Comparative Philosophy)** having its principal office at Nalanda Vihar, Kusunur Road, Kalaburagi-585 106.

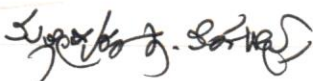
WHEREAS:

The Parties recognize the value of academic and research collaboration, and have agreed to pursue their common interest in promoting mutual cooperation in the areas of teaching, research, publication, capacity building, training, development and promotion of philosophy of Pali, Prakrit and Sanskrit Studies.

THUS:

The Parties agree to implement the MOU under the terms and conditions hereinafter set forth, and,

The Parties agree whereas the research and teaching cooperation proposed in this document covers Humanities and Languages, Philosophy, Logic, Psychology and Performing Arts and it may be extended to other disciplines in future by mutual agreement.

The terms and conditions of the MOU are as follows:

1. Translation of Pali, Prakrit and Sanskrit literatures into English and Kannada.
2. Undertaking minor projects related to Pali, Prakrit and Sanskrit languages.
3. Organising and conducting International and National Seminars, workshops and symposiums related to Pali, Prakrit and Sanskrit languages, literatures and philosophies.
4. Propagating Pali, Prakrit and Sanskrit Languages.
5. Conducting programs related to Pali, Prakrit and Sanskrit languages for students, teachers and the faculty.
6. Organising and conducting state level workshops related to the relation between Pali and Kannada, Pali and Sanskrit and Pali and Prakrit.
7. Creation of Audios, Videos on Pali and Prakrit texts and digitalising the same.
8. Offering Certificate and Diploma courses with mutual agreement and as per the norms of Central University of Karnataka for which an extended agreement will be made.
9. **Joint Research Projects:** CUK and Pali Institute will undertake joint research projects in joint authorship. Funding and other operational modalities will be discussed on need basis at an appropriate time.
10. **Capacity Building Programs:** CUK and Pali Institute will organize capacity building and personality development programs for students, faculties and others. Cost and revenue sharing will be discussed as and when such programs are organized.
11. **Organising Seminars/Workshops:** The Parties will organize the seminars and workshops jointly either on CUK Campus or Pali Institute premises.
12. **Infrastructure Sharing:** CUK and Pali Institute will extend infrastructure facilities to each other to organize academic and other activities at the national and international levels and the use of such infrastructure facilities will be subject to availability and on payment of minimum user charges/free.
13. Pali Institute will work as a nodal centre for all the above mentioned activities and the School of Humanities and Languages will implement the clauses of this MoU at all levels on behalf of Central University of Karnataka, Kalaburagi.
14. The following Committees/Boards will execute/look after the activities mentioned in the agreement.

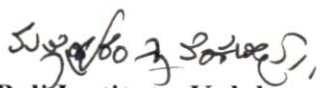
Amendments, Duration and Termination

1. Any amendment to this MoU can only be made in writing after consultation and mutual consent of the two parties. Such amendments, once approved by both parties, will become part of this MoU and are incorporated by reference;
2. The effective date of this MoU shall be the date on which the both the parties hereto execute their original of this MoU;
3. This MoU shall remain in force for a period of 5 years from the date of the last signature. The MoU may be extended by mutual consent of both the parties; and,
4. The MoU may be terminated by either party by giving a written notice at least three months in advance. Termination of the MoU will not affect the ongoing activities/projects at the host institute or at the University.
5. The Pali Institute shall take care of the expenses of the academic, research, translation activities proposed in the MoU and the expenses of making of audios, videos, short films, movies will also be borne by the Pali Institute.
