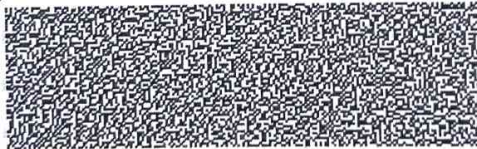
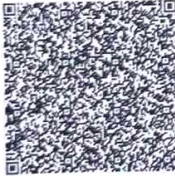

**MEMORANDUM OF UNDERSTANDING BETWEEN
HERITAGE FOUNDATION, JALGAON, MAHARASHTRA
AND**

CENTRAL UNIVERSITY OF KARNATAKA, KALABURGI

This Memorandum of Understanding (MoU) is made between Central University of Karnataka situated at Kadaganchi, Kalaburagi-585367 and Heritage Foundation with Head office at Bungalow

No. 4, Tapovan Cooperative Housing Society, Ram Nagar, Bavdhan, Pune – 411021 (MH) and registered office at 402, Matoshree App. Plot No. 15 Sr. No. 462/1, Devendra Nagar, Jalgaon – 425001 (MH) . The scope of this Memorandum of Understanding (MoU) is intended to develop research and academic cooperation between the Heritage Foundation, and the Central University of Karnataka. The Central University of Karnataka is hereby assigned as the First party and the Heritage Foundation, Jalgaon, Maharashtra assigned as the Second party.

1. PREAMBLE

The Central University of Karnataka has been established by an Act of Parliament (No. 3 of 2009) at Kalaburagi, Karnataka and the main objective of this University is to integrate teaching, learning, training, research, innovation, and skill development with an aspiration to *excel* in undergraduate, postgraduate, and doctoral studies for rendering excellent educational, technological, and knowledge services to society.

Heritage Foundation is a registered (registration no. Jal/0013/2021/Mah/21692) organization in 2021. It works in the field of Manuscript documentation, Cataloguing, Digitization, Conservation-Preservation, and provide training in this field. It also provides expertise for establishing Museums and Research Centers in India for to Save Heritage and make it a part of Education.

2. PURPOSE :

A) This MoU establishes research and academic cooperation between the Heritage Foundation, Jalgaon and the Central University of Karnataka, Kalaburgi. Under this MOU, both institutions will extend their cooperation in the preservation and digitization of manuscripts, training the students, sharing digitized manuscripts for the students and researchers working in both organizations.

B) Planning for the conduct of joint workshops, seminars, conferences and developing allied research and museum institutions.

C) Provide internship and training programmes for the students in the field of Heritage conservation and preservation.

3. AREAS OF COOPERATION

The Heritage Foundation, Pune and Central University of Karnataka, Kalaburagi, or their authorized representatives, agree to explore the possibility of engaging in the following collaborative activities in academic and research areas of mutual interest: Preservation and digitization of the manuscripts, training the students in the preservation and digitization of the manuscripts, sharing the digitized manuscripts for the researchers and developing the museum. Either of the parties shall not use the identities of them in the benefiting any third parties and function with them beyond the scope of this MoU.

4. Details of the proposed research/ academic cooperation:

a. Objectives:

- To train the students in preservation and digitization of the manuscripts.
- To enrich the research by sharing the digitized manuscripts.
- To develop a manuscript gallery in the museum.
- Engaging students in the internship programmes.
- Further expansion/development of museum..

b. Expected outcome

- Skill development among the students.
- Development of museum
- Enriched research atmosphere.
- Successful completion and certification of internship.

5. Duration of Collaboration/ or cooperation: Three years from the date of signing.

6. Terms and conditions:

- a. **Financial Liability:** The Central University of Karnataka shall not bear any financial obligations in the execution and functioning of this MoU. The quantum and type of any financial obligations in sourcing funds for nay said programmes/ activities shall be mutually discussed by both the parties before the commencement of work.

- b. **Intellectual Property:** Important research findings and inventions developed under the collaboration may be published/ presented/ patented with the mutual consent of the collaborators. Any returns through commercialization of the Intellectual property will be shared in proportion to be decided mutually by both the parties on a case-to-case basis.
- c. **Non-exclusivity of the MoU:** Except the provisions regarding Intellectual Property, either party or both parties together will have an unrestricted right to seek additional funds for and/or to cooperate with any agency/institute for any of the projects covered in the MoU.
- d. **Rights for modifications:** The contents of the MoU may be modified or changed by mutual agreement of the parties hereto in writing. It shall then be effective from the date of modification with the approval of competent authorities.
- e. **Confidentiality:** Party I and Party II shall maintain the confidentiality of the data and can be made public or put on disclosure with mutual consent if necessary. Both the parties agree that they will mutually discuss and consent, before releasing any information into the electronic media/ press to avoid any misuse by third parties.
- f. **Disagreements/ Differences:** Any disagreements/ differences of opinion/ disputes regarding the interpretations of the provisions of the MoU shall be resolved by mutual consultation of the signatories.
- g. **Governing Laws:** The research undertaken under this MoU will be governed by the Laws of the Republic of India and ordinance/rules of governing agencies of both the institutions.
- h. **Termination and Renewal:** Either parties may terminate the agreement with prior notice of 3 months and endeavor to settle through mutual discussions in any issues arising during the period of active MoU. Unless chosen otherwise by either of the parties to the MoU, tenure shall be renewed for another three years from the date of expiry of the first tenure depending on suggestion of the standing committee.
- i. **Ethical Clearance:** This MoU is not in the content or scope of animal and human trails and solely focus on the manuscript and artifacts. Ethical clearance shall be of consent in particular to obtaining ownership/ copy rights from the donors in regulating the manuscripts in conservation and preservation of them.

- j. In case of animal/human trials or any equivalent procedure the ethical clearance shall be duly obtained from the appropriate bodies of both the institutions.
- k. **Report:** A duly signed detailed report shall be submitted with outcome and recommendations at the end of the tenure as well as yearly for evaluation.

8. Hosting department and representative: The Central University of Karnataka nominates the Dept. of History and Archaeology to hold the execution of this MoU, and nominates Dr. Ravi Khangai, Associate Professor and HoD of Dept. of History and Archaeology as coordinator/ representative. From the Heritage Foundation nominates Sri Bhujang Ramrao Bobade, Director, Heritage Foundation, and Mr. Sachin Pawar, Assistant Director, Heritage Foundation as coordinator/ representative to execute this MoU.

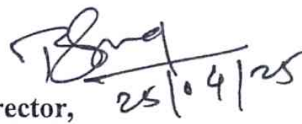
7. Declaration:

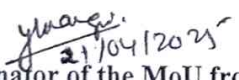

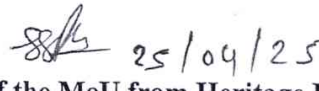
